Montevallo Police Department Stats

Chief Reid presented the report from the Fire Department. He informed the Council that we received three bids for the Snorkel truck. The high bid was for \$3,500 from Anthony Marcus, a member of the Southern Vintage Fire Apparatus Association. He asked the Council to consider allocating the

proceeds from the sale of the snorkel truck for additional improvements at Station 1. He said the \$3,500 could be used to complete the kitchen and second restroom.

Mayor Cost suggested there be another meeting to look at remaining sidewalk improvements.

Shane Baugh, Director of Parks & Recreation, informed the Council that basketball season starts Wednesday. He said the last two games will be at home, so they should draw a lot of visitors to Montevallo.

Lauren Bartell, Director of the Parnell Memorial Library, reminded the Council that Christmas with Mrs. Claus will be December 1st. She also informed them that the State Trail Commission meeting will be held at the library and that they will be provided a tour of Orr Park while they are here.

Abigail Heuton updated the Council on the activities of the Montevallo Junior City Council (MJCC):



Mayor Cost reminded everyone that the Montevallo Sister City Commission is sending a delegation to Japan next summer. She noted it is time to renew our Sister City Agreement with Echizen. Last time

they sent a delegation here. We will be sending a delegation to Japan next October. We will need to include that cost in our budget for next year. We will be sending 6-8 representatives.

Council Member Walker suggested that we need to reschedule our second council meeting in December because it falls on Christmas Eve. He also mentioned there will be a Historical Commission meeting Tuesday night.

Montevally Main Street Director, Courtney Bennett, reminded the Council that the Christmas Parade is Thursday night. The annual tree lighting ceremony will be at 5:30. Once again, Montevally Main Street sponsored a Holiday Window Display Competition among downtown businesses, and the winners will be announced at the tree lighting ceremony. She thanked the city workers and everyone else who helped to decorate downtown so beautifully again this year.

Council Member Bunt reminded everyone that Montevally Elementary School is hosting Supper with Santa after the parade.

Mayor Cost then reviewed the Agenda items with the Council. She said the Video Agreement involves a project featuring Montevally at no cost to us. Local businesses will pay to be featured in the video. She said this will be a great way to promote our city.

Council Member Bunt mentioned that the University has had great success using short videos as a marketing tool.

With regard to the proposed purchase of the Victory Building, Mayor Cost said she has a meeting scheduled with the owners at the end of the week.

Mayor Cost noted there are several openings on our boards and that she will be bringing forward recommendations at upcoming meetings.

In Other Business, Mayor Cost said we have received complaints about speeding along Middle Street near the intersection of Oak Street. She said we need to revisit ways to slow down the traffic in that area.

Chief Littleton suggested we contact the County about that issue since that is a County road.

Council Member Nix expressed concern that adding a stop sign at that intersection could be a problem for trucks attempting to start up the hill.

Council Member Walker said he can confirm that trucks speed along that road every day.

After some additional discussion regarding the council meeting on the 24th, Mayor Cost said we would post a notice that the meeting that night is cancelled.

Council Member Nix informed the Council that he has received a lot of positive comments regarding the new Christmas decorations and lights along Main Street.

Mayor Cost said Pam Phagan and the Main Street Design Committee did an excellent job designing the decorations downtown.

The Mayor suggested the Graham Street owner have a clearer understanding of what we expect him to do in order to avoid further action. Council Member Nix suggested we also add a 90 day time limit.

Mayor Cost asked if there was anyone in attendance to comment on any of these properties. No one responded. The Mayor closed the hearing at 6:06 p.m.
