## AN ORDINANCE AMENDING ARTICLE III, SECTIONS 2-50 and 2-53 OF THE MONTEVALLO MUNICIPAL CODE

WHEREAS, the City of Montevallo, Alabama desires to keep its Municipal Codes current; and

WHEREAS, certain amendments to the Code are from time to time required;

## NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF MONTEVALLO, ALABAMA, AS FOLLOWS:

1) Article III, Section 2-50 of the Code of Ordinances, City of Montevallo, Alabama, is hereby amended to read as follows:

## Regular council meetings.

Regular meetings of the council shall be held on the second and fourth Monday of each month, at 6:00 p.m. at the city hall or wherever else the council shall determine. Council Work Sessions shall begin at 5:30 p.m. that same evening; and

2) Article III, Section 2-53 of the Code of Ordinances, City of Montevallo, Alabama, is hereby amended to read as follows:
