Mayor Rusty Nix, Council Member Lelia Mitchell, Council Member Kenneth Dukes, Council Member Sonya Swords, Council Member Martha Eisenberg, were in attendance. Council Member David King absent present by Zoom Meeting

Mayor Nix opened the work session at 5:30 p.m.

Chief Littleton presented the Police Department Monthly Report.

Chief Davis for Fire Department Monthly Report. See Appendix 2

Planning and Zoning meeting last Thursday, February 18th. Discussion regarding the rezoning request was withdrawn on Case No. SN20-026 – Colonial Oaks Phase 7 – Preliminary Plat. Parking Requirements in the Urban Core was discussed, as well as, site plan requirements for B2; D4 is scheduled for a March 11 work session so commission can review.

Councilman Dukes called on Kirk Hamby, Public Works Director, new LED streetlights have been installed on N. Boundary Street. An inventory of the banner arms on light poles downtown has been conducted and replacements will be ordered to replace those that have been damaged. A list of surplus equipment is being compiled for auction. Council will need to approve for liquidation.

Councilman Dukes called on Oliva Barone, Sustainability Coordinator. she reported on the streetlights at the intersection of Highway 119 and 25. They are out, and Alabama Power has been notified of the issue for repair. Free Dump Day will be held Saturday March 27th at the Shelby County Landfill. 25 tons of materials were recycled in January, 40 tons year to date. See Appendix 3

Councilman Dukes called on Arthur Herbert for the Vallo Cycle report. Their next meeting is Thursday March 4th at 6:00 PM at City Hall. The Wellness Ride has been postponed.

Shane Baugh, Parks and Recreation Director reported that planting trees at Orr Park has been completed a total of 9 trees were planted in the park and 1 planted at Parnell Library garden. The wind Screen has been installed at Orr Park Baseball field. Community Eater Egg Hunt will be April 3rd at Orr Park. Youth Sports Season begins this week. Birding Trail signs have been installed at Shoal Creek Park. Architect is to conduct an inspection of the work on Mahler House for final approval.

Councilwoman Mitchell called on Impact Director Sarah Hogan. Junior Mayor Olivia Gilbert gave a report from the MJCC. See Appendix 4.

Councilwoman Mitchell called on Savannah Kitchens Library Director for the Library Report. The Dial -A-Story Program is operational. Anyone can dial in and hear a story. The Hoopla App. will be available March 1, this will allow those with library cards to access free movies. See Appendix 5.

No report from Artwalk or Boys and Girls Club. No report from Sister City Commission. The American Village Festival of Tulips has been delayed because flowers have not bloomed.

Schools will be closed for a Teacher Workday March 12th. The university of Montevallo has been named as one of the Top Graduate Programs in America.



To allow for a socially distanced event, the trees will be available from 9:00 am until 3:00 pm or until supplies run out. As in the past these trees will be free. For safety reasons we will not have drawings for potted trees and shrubs, and we do not know yet if mulch and potting soil will be available.
 - The trees available should include Pecan, Redbud, Dogwood, Ginkgo Biloba, Magnolia, several types of Oak and American Snowbell.

Ms. Sarah Hogan called on Junior Mayor, Ms. Olivia Gilbert for her report. Due to technical difficulty, Sarah asked Olivia to send her report in the chat to read following the Impact Montevallo report. Sarah provided the following updates from Impact Montevallo:

- **Current legislation:** Coalition members are staying apprised and advocating regarding two proposals currently under legislative review:
 - **2021-SB 46: Compassionate Care Act: Medical Marijuana**
 - SB 46 would allow qualifying Alabamians, qualified meaning diagnosed with certain medical conditions, to register for and obtain a medical marijuana card. ... Smoking, vaping or ingesting marijuana infused baked goods, even in possession of a medical card, would remain illegal in Alabama
 - Advanced from the State's Senate Judiciary Committee
 - 25% Progression
 - **2021 – SB 126, SB 128 & HB 229: Alcohol Home Delivery**
 - The bill would allow home delivery of distilled spirits in original containers from package stores, and from restaurants and bars with a meal purchase.
 - SB 126: 50% Progression; Passed to the House Judiciary Committee
 - HB 229: 25% Progression
 - SB: 128: 25% Progression; Referred to the Senate Committee on Tourism

- **Grant Updates:** I completed and submitted the Semi-Annual Progress Report for the Drug-Free Communities Support Grant to the CDC. We look forward to receiving feedback on the coalition accomplishments over the last 6 months.

- **Seeking input for Youth Social Events:** The coalition has received funding to host a quarterly substance free social events to promote positive behaviors. If you have any ideas, please send me a email. A link to provide input will be released on our Facebook page tomorrow.

Ordinance No. 02082021-311**An Ordinance Amending Chapter 4, Article II (Animal Control) of the Municipal Code of Montevallo**

Whereas, the City of Montevallo desires, to the greatest extent practicable, to do everything it can to protect the health and welfare of animals within its city limits; and

Whereas, a group of concerned citizens has conducted public forums, solicited public and city staff input regarding possible changes to our codes; and

Whereas, they have recommended certain amendments to our code, which would greatly, improve our ability to protect the health and welfare of animals living within our community.

NOW, THEREFORE, BE IT ORDAINED as follows:

- 1) Chapter 4-ANIMALS, ARTICLE II-ANIMAL CONTROL, Sec. 4-27. -Penalties shall be amended to read as follows:
 - a. Any person found guilty of non-compliance or violation of the ordinance set forth in sections 4-21 to 4-41 of this document shall be liable for any and all costs incurred in the apprehension, detention, kenneling and medical treatment of any dog whose owner is in violation and shall be fined \$50.00 plus any costs for the first offense; \$100.00 plus any applicable costs for the second offense \$200.00 plus any applicable costs for third offense and may be jailed at the discretion of the municipal judge up to the limits of municipal jurisdiction for fourth and subsequent offense.
- 2) Chapter 4 -ANIMALS, ARTICLE II -ANIMAL CONTROL, Sections 29, 30 and 31 shall be added as follows:

Sec. 4.29. - Duty to provide for animal health.

It is the intent of this ordinance to keep animals and citizens safe and happy. Our goal is to educate animal owners on best practices to ensure the health and wellbeing of their pets. We consider rehoming animals to be a last resort, only used if attempts to improve the animal's living conditions have failed.

- 1) It shall be the duty of any animal guardian or owner of property where the animal is contained to provide adequate clean, fresh potable water available to the animal continuously, which is of adequate amount for the animal's size, age, breed, health, and environment in which the animal is kept, to prevent overheating or dehydration.
- 2) It shall be the duty of any animal guardian or owner of property where the animal is contained to provide adequate fresh food in amounts sufficient to maintain adequate levels of nutrition suitable to the health of the animal based on size, age, health, and physical condition.

Sec. 4.30. - Duty to properly restrain dogs on private and commercial property.


- 1) It shall be acknowledged as the responsibility of every dog owner or owner of premises where the dog is housed to keep the animal within effective, humane, and hygienic restraint. It shall be unlawful for a person responsible for any dog to fail to maintain a dog under proper restraint as outlined in the following order. Failure to provide or maintain effective restraint shall be deemed unlawful.
- 2) It shall always be the duty of every person having custody or control of a dog to physically restrain the dog when left unattended outdoors. The dog should be restrained such as to prevent the dog from leaving the premises of its owner or coming in contact with the public unsupervised.
- 3) Proper restraint will be defined as confinement within a fenced enclosure with adequate space for ease of movement and adequate exercise based on the animal's breed, age, size, health, coat, and medical condition. Enclosure must be made of fencing meant for containing an animal (i.e., chain link, wood, or similar material). Fencing must be of sufficient height to prevent animals from escaping.
- 4) An animal that can bite or snap through fencing shall not be considered properly enclosed.
- 5) Multiple dogs that fight each other shall not be kept together in the same enclosure at any time, for any length of time.
- 6) Dogs may be restrained by means of a trolley system attached to a pulley on a cable provided the following requirements are met:
 - a. Trolley restraint shall be affixed in a manner that allows the dog free movement along the trolley, prevents the dog from becoming entangled, wrapped around any object and does not allow the leash to be shortened to allow for injury, strangling or restricting access to food, water, and shelter.
 - b. The trolley restraint shall be of proper weight for the dog and shall be affixed to a properly fitted harness or collar with a swivel attachment. The harness must be made of a suitable material other than metal or chain and shall not cause damage or injury to the dog's skin. Choke collars, pinch collars, and chains collars shall be deemed unlawful type restraint for tethering a dog to a trolley system.
 - c. Only one dog shall be tethered to one trolley system.
 - d. There shall be a swivel attachment on both ends of the attachment to help prevent tangling of the tether.
 - e. The size and weight shall be of adequate size to restrain the dog but shall not be of excessive weight as determined by Montevallo Animal Control Officer considering the size, age, strength, and health of the dog.
- 7) The length of the tether from the cable to the dog's harness shall allow access to reasonable exercise and shall always allow continuous access to clean potable water, adequate food, and suitable shelter.

- 8) The length of the cable tether shall be of appropriate configuration to confine the dog to the owner's property, to prevent the tether from entangling in or extending over an object or edge that could cause injury to the dog.
- 9) A dog may not be left on a tether more than twelve consecutive hours or overnight.
 - (a) Dogs may be tethered to a stationary object only if conditions (1) - (8) are met:
 - (1) A tether shall be equipped with a swivel on both ends.
 - (2) A tether shall be a minimum of ten feet in length and shall be made of either metal chain or coated steel cable.
 - (3) Tethers shall be attached to a buckle-type collar or harness and under no circumstances shall the tether itself be placed directly around a dog's neck. Tethers shall not be used in conjunction with training collars such as choke or pinch-style collars.
 - (4) The weight of the tether shall not exceed ten percent of the total body weight of the dog but shall be of sufficient strength to prevent breakage.
 - (5) The tether by design and placement shall allow the dog a reasonable and unobstructed range of motion without the possibility of entanglement, strangulation, or other injury. The tether shall allow the dog access to adequate food, water, and shelter.
 - (6) Only one dog shall be attached to a single tether.
 - (7) An animal control officer may in his/her discretion order a more restrictive tethering requirement if circumstances require and it is not detrimental to the health, safety, or welfare of a dog.
 - (8) Exemptions. Citizens residing in townhomes, apartments, condos or similar multi-family housing units with lot sizes insufficient to meet the length and property line requirements specified in subsection (2) above, may only tether dogs for temporary exercise and relief.

Sec. 4-31. - Duty to provide adequate shelter.

- (a) Any animal that is habitually kept outside or repeatedly left outside unattended shall be provided with structurally sound, moisture proof, windproof shelter large enough to keep the dog reasonably clean and dry. A shelter which does not adequately protect the animal from temperature extremes or precipitation, or which does not provide adequate ventilation and drainage shall not comply with this section. Adequate protection from temperature extremes shall be determined by Montevallo Animal Control officer and shall be determined based on breed, age, size, health, coat condition and medical condition of the animal.
 - (b) The shelter shall be large enough for the animal to enter, stand, sit, lie down, and turn around in a normal manner.
 - (c) Area immediately surrounding shelter shall be maintained in a manner to remain clean, free of excessive excrement, and have drainage adequate to maintain a dry floor and inside.
- 1) Sections 4-32-4-59 shall be Reserved.
