Kirk Hamby, Director of Public Works, said the Electronics Recycling Day was held at the Recycling Center last Saturday. He said we need to come up with a plan to address the disposal of old TVs. Lately, his crews having been picking up a lot of old mattresses, sofas, etc. from along the streets. He said we need a plan to dispose of all these types of items. Related to that, he noted that the Saturday litter clean-up campaign has been very effective.

With regard to animal control, Mr. Hamby mentioned that we are styli receiving a lot of animal complaints. We are taking more animals to the Humane Society and others from our city are dropping even more off. On top of that, the amount we pay per animal has increased to \$82. As a result, we are going over budget ion that line-item.

Council Member Nix asked about the procedures the County has in place to ensure that the animals that are being dropped off and billed to us are really coming from Montevallo.

Mr. Hamby said it really is a question that is hard to answer. People may tell them they found the animal in Orr Park , then we get billed.

Council Member Nix suggested we talk to the County to see what can be done to get better control over the situation. Council Member Peterson agreed.

Mr. Hamby said other communities negotiate a flat rate with the county and suggested we may be able to do the same.

Council Member Bunt said she thought that would be worth exploring.

The City Clerk said we can request a meeting with the County to discuss these issues.

Council Members Nix and Peterson said that would be a good idea.

Mr. Hamby updated the council on activities at Park & Rec, as well. He said the League program started last week. We had a travel ball tournament in town over the weekend. We have two volleyball teams this year. He also mentioned there will be a there will be a big track & field even at UM this weekend.

Council Member Nix reported that revenues at the Golf Course ae up over the same period last year. He said the Trail Committee has been working to identify se4ctons of the trail in Orr Park and other spots which can be made ADA compliant. Some sections of the trail are not able to be made fully accessible.

The City Clerk said the trail map at the park could identify those sections which are accessible and those that are not.

Council Member Nix reminded the Council that the Planning Commission will meet April 6<sup>th</sup> at 6:00 PM to discuss the site plan request from Taco Bell.

Council Member Bunt informed the Council that the Sister Coty Commission met and is working to identify students interested in participating in the Echizen program this summer. Council Member Walker reminded everyone that the Finance Committee meets Wednesday at 4:30 and the meets the following Tuesday.

Council Member Nix said he attended the MDCD meeting and they approved approximately \$27,000 in funding for conduit installation along Main Street. This will allow UM the opportunity to bring Wifi for their students downtown.

Council Member Peterson explained that UM will run fiber in the conduit from UMOM. It will be used to serve the student initially but having the conduit in place would open up possibilities for other improvements in the future.

Chief Littleton discussed the Light Package bids with the council. We received bids from 2 companies, Brasher Electronics and Haynes. The results are as follows:

The Chief said they have never used that Haynes before but that the Fire Dept has and the company has a good reputation. In addition, the products they quoted are of similar or better quality than the other bid. Therefore, he recommended the council approve the Haynes bid.

The City Clerk informed the Council that our crews at the Golf Course are still working to improve the irrigation system. They are requesting an additional \$3,200 in funding for the project. This is still within their original \$10,000 budget.

As far as the Parental Alienation Proclamation is concerned, the City Clerk said this is the same thing we have done for several years now. With regard to the EPA letter, he explained that our grant writer suggested we notify our Congress members and encourage them to oppose any efforts to reduce grant funding. He also said there were no updates on the ALAGASCO agreement but would make an effort to reach out to them again.

## PROCLAMATION

**WHEREAS:** Strong family relationships constitute the foundation of our community; and

**WHEREAS:** Alienating behaviors are frequently seen in high-conflict divorces, separations and asymmetrical custody arrangements but can occur in intact marriages; and

**WHEREAS:** Parental Alienation is a term used to describe any number of behaviors and attitudes on the part of one parent, both parents or third party designed to interfere, damage or destroy the relationship a child has with their other parent. It's a form of abuse that causes emotional trauma to children; and

**WHEREAS:** Parental Alienation deprives children of their right to freely love and be loved by both parents, their extended families and robs children of their sense of security; and

**WHEREAS,** we encourage all Alabamians to visit [paawareness.com](http://paawareness.com) for information on raising awareness to stop Parental Alienation, and we call on community and state leaders to support shared parenting because of its benefits for children.

**WHEREAS:** The recently published Diagnostic and Statistical Manual of Mental Disorders (DSM-5) made several references to the dysfunctional family dynamic of alienation to be a form of psychological child abuse; and

**WHEREAS:** Approximately 40,000 children in the State of Alabama were subjected to child custody determinations in 2014; and

**WHEREAS:** Parental Alienation Prevention Week is intended to increase the knowledge and understanding of this problem to help Alabamians, institutions, the legal and mental health community and leaders to better identify and combat this abusive behavior to children; and

**WHEREAS:** God so loved us, we also ought to love one another; love does no harm to its neighbor; therefore Children should be able to freely express the meaning of F.A.M.I.L.Y. (**F**ather **A**nd **M**other, **I** Love **Y**ou); and



**WHEREAS:** In honor of Parental Alienation Prevention Week, come and show your support by taking 10 minutes out of your day at noon, on Tuesday, April 25, to blow soap “Bubbles For Love”. Each bubble we blow represents the love our children have and should be allowed to share with both their parents.

**RESOLUTION OPPOSING THE PROPOSED REDUCTIONS IN  
FEDERAL FUNDING FOR U.S. EPA BROWNFIELDS GRANTS**

WHEREAS, funding by U.S. EPA of Brownfield Grants are instrumental for economic development in the State of Alabama; and

WHEREAS, the proposed budget for U.S. EPA includes a 44% reduction in Brownfield Grants from EPA (\$25 million (2016) reduced to \$14 million (2018)) and a 31% reduction in Brownfield State Grants from EPA (\$48 million (2016) reduced to \$33 million (2018)),

WHEREAS, the City of Montevallo has potentially critical environmental issues which have hindered the redevelopment of our historic downtown and other areas of our community; and

WHEREAS, the City of Montevallo has applied for and hopes to receive EPA grant funding to assist our community in identifying and developing a plan to address certain environmental concerns; and

WHEREAS, the significance of the economic contributions provided by brownfield development, and the importance of State and Federal investments to generate these economic benefits cannot be overstated;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Montevallo, Alabama that we hereby stress our community's opposition to any reduction in U.S. EPA funding of these grants and that we believe strongly that the levels of grant assistance should be kept at the 2016 level in order to support the future economic development of brownfields projects in the City of Montevallo, the State of Alabama, and other cities and states throughout our nation.

BE IT FURTHER RESOLVED that the City Clerk is hereby directed to send a copy of this resolution to each member of the Alabama Congressional delegation.
