### Selma Road

### **Historic Black Business District**

The Black Business and Entertainment District along Selma Road developed during the Jim Crow era. Most, if not all, of the commercial establishments were rented from a well-to-do African American couple from Marion, AL, Hampton D. Lee and his wife Exie P. Lee. It was the Lees who in 1948 sold the state of Alabama the tract of 15 acres along Selma Road that became Prentice High School and is now the site of Montevallo Middle School and George Dailey Park.

The district served as the business, social, and cultural center for blacks in the Montevallo community. The Lee Funeral Home offered an ambulance service, a notary public, and a burial association. It was operating by the early 1940s. Some of the workers were John Smith, Walter Taylor and Roosevelt "Sam" Cunningham. Other businesses included an Owl filling station, run by Andy Smelley and Ms. Heard; a cleaners operated by Hobie Harris; a pool hall (for men and boys only).

A barbershop was owned and operated by Tom Billingsley. There was also a taxi service. The taximan may have been the same John Smith who drove the ambulance for Lee Funeral Home. Coleman's Café, operated by Mable and Walter Coleman, sold soul food on one side and maintained a dance floor on the other side. The "Sensation Heartbeats" played at Coleman's and other local areas. It came under new management in the 1970s, bought by Sam Lilly, who renamed it The Superfly Club. There was another dance joint in the area called Slim's Place that was owned by Tellie

Cunningham. Many of the businesses ended due to the end of segregation and the death of the owners.

### Montevallo Historic Preservation Commission presents

### UNTOLD STORIES OF BLACK MONTEVALLO

Your Historic Preservation Commission is working to create a first-rate Montevallo African American Heritage Trail. In coming months we will use this space to share some of our discoveries.

We focus today on Black business enterprises. We begin at the end of the 19th century in the nearby coal mining village of Aldrich, now an unincorporated part of Montevallo. Remarkably, Aldrich was home to a weekly Black-edited newspaper, The Alabama Time-Piece, which ran for a number of years beginning in 1895. It was edited by B. L. ("Booker") Lester, who was also principal of the Aldrich grammar school. (The grammar school seems to have been progressive. The 7th grade course of study included not only bookkeeping but also "Negro History.") We will return to the fascinating story of of The Alabama Timethe Alabama Time-Piece in a later Piece, c. 1900 installment.

Advertisements from the 1898 Time-Piece give intriguing glimpses of Black-owned businesses in Montevallo at the turn of the century. One businessman, Richard D. Taylor, was born into slavery in 1855. By at least 1900 he owned his own home. One of his neighbors was H. C. Reynolds. His store, located just behind the post office, offered confectionary, cakes, and candles as well as "FRESH GROCERIES." His appeal to his readers gives the flavor of the spirit of Black entrepreneurship of the times: "Call on him," the ad says, "if you want to practice race pride, and also get the most for your money."

Another businessman was Robert B. Evans, who, like many at this time, may also have worked as a coal miner. He points with pride to "the only first class Colored Barber Shop" on the east side of town. He urges: "While in the city call on him and be treated right."

An ad of unusual interest was placed by a man still revered in some local circles, Rev. Joseph S. Prentice (1857-1944) for whom the beloved Prentice High School was named. Prentice, whom you will meet again in this space, was acclaimed as a Baptist preacher and educational leader. The Bibb County Baptist Association installed a monument in his honor in 1945, which can be seen in the Montevallo City Cemetery (or on Findagrave.com).

In 1898, Prentice not only pastored three churches in Bibb Co and our own Shiloh Baptist here in Montevallo; he was also venturing into the merchant line. On May 5 he wrote to the editor of the Time-Piece: "Rev. Prentice & Sons have opened a Grocery Store on his lot, near the Time-Piece office, for the accommodation of all," with ECIAL prices to Church Schools and Secret He signs off: "Don't your pocket book."

Moving forward, some will recall the Black Business and Entertainment District along Selma Road during the Jim Crow era. Most, if not all, of the commercial establishments were rented from a well-to-do African American couple from Marion (AL), Hampton D. Lee (1898-1971) and his wife Exie Patrick Lee (1902-1996). After WWI (in which he served), Hampton opened a funeral home in Marion that offered "prompt and efficient service"; before long he was wheeling and dealing in properties across central Alabama, Rev. Albert L. Jones remembers him as "really smart," a "wheeler dealer" with good hair. He does not know how Lee came into his property or wealth but thinks he had a white father. It was the Lees who in 1948 sold the state of Alabama the tract of 15 acres along Selma Road (for \$3750) that became Prentice High School and is now the site of Montevallo Middle School and George Dailey Park. Dailey was our first African American city council member.

The Lee Funeral Home in Montevallo offered an ambulance service, a notary public, and a burial association. It was operating by the early 1940s. A number of names have been linked with its daily operations: John Smith, Walter Taylor, Sam Cunningham, and a Mr. Foster. Other businesses along Selma Road included an Owl filling station (run by Andy Smelley and Ms. Heard); a cleaners operated by Hobie Harris; a pool hall (for men and boys only).

A barbershop was owned and operated by Tom Billingsley and an additional barber, Tommy Patrick of Wilton. Rev Jones recalls working as a teenager in its shoeshine stand. A boot shine cost 25¢, a shoeshine 15¢. He got to keep a nickel for each, plus tips. There was also a taxi service (since few blacks owned cars) that advertised itself with a phone number on the side of the vehicle. The taximan may have been the same John Smith who drove the ambulance for Lee Funeral Home.

Coleman's Cafe, operated by Mable and Walter Coleman, sold soul food on one side and maintained a dance floor on the other. It came under new management in the 70s, bought by Sam Lilly, who renamed it The Superfly. It is said that the "Sensation Heartbeats" played at Coleman's and other local areas. The members included Sam Cunningham (alto sax), Chuck Chism (guitar), deceased drummers James Trenholm and Larry Deviner, and several other band members who have passed away. There was another dance joint up the street called Slim's Place (owned by Tellie Cunningham), at the site of the present Good Shepherd funeral home. Tellie was Earl and Sam Cunningham's uncle.

Montevallo produced at least one piano player who made

it into the Encyclopedia of the Blues, Piano C. Red (1933-2013). He performed in Chicago with such greats as Muddy Waters, B. B. King, and Fats Domino. The son of Lucille Fain, he was taught to play by Thomas "Fat' Lilly who lived just to the left of the present Good Shepherd Funeral Home.

### Montevallo's Prentice High School

Montevallo Negro High School - later to be known as Prentice High School - officially opened its doors in 1950. Prior to its creation, black students in the area who wanted to go beyond the ninth grade were bussed to Columbiana to County Training School.

First steps toward the establishment of the school were made in February, 1948, when a motion passed during a meeting of the County Board of Education to have plans made for building a high school in Almont. In May of '48, the site was moved to Montevallo and the suggested property (a 15 acre tract on Selma Road known as the old Kendrick property) was purchased from a prominent

black business man -Hampton D. Lee and his wife, Exie Patric Lee - for the sum of \$3750.00.

The building, set to be finished in September of 1949, was not completed until March of 1950. During the time from September to March, students attended classes in the Masonic Hall, Ward Chapel AME Church and Pilgrim Rest Church.





The 1949-1950 faculty was headed up by Luther L. Penn as principal. Samual Maull and Marie Peoples were sponsors for the first graduating class. The 62 member class held their ceremony utilizing a platform for a stage in one of two adjoining rooms that could be opened into one by means of a movable wall.

In September of 1950, it was obvious that more space was needed and six additional classrooms plus a home economics area were added to the original six room structure. A combination auditori-

um - gym was completed in March, 1955.

Between 1951 and 1954, mail delivery became a problem because of confusion between the names of the all-white Montevallo High School and M.N.H.S. A group of citizens met and decided to rename the school in honor of a long-time resident and leading citizen - the Rev. Joseph Prentice.

With the renaming of the school, and the addition of competitive sports to the program, a true "identity" became established. Green and gold were chosen as school colors and a mascot - the dragon - was selected.

C.P. Everett became principal upon the retirement of Mr. Penn in 1960 and in September,

construction of two more classrooms and a lunch room were

approved.

In 1965, George Dailey was named principal - at a time when decisions and guidelines were being issued from Washington, D.C. concerning the desegregation of public schools. The days of all-black Prentice High were numbered.

In 1968, a Freedom of Choice letter was distributed to all students giving them the opportunity to attend the school of their choice for the 1968-69 term. Some teachers long associated with Prentice became a part of the faculty of Montevallo High. One of


these teachers, Mrs. Blanche Coger, who had been a part of the Prentice faculty since the school's opening 1949-50 term, was especially revered. Her students and co-workers, both black and white, had great respect for her and honored her in a special tribute at a reunion of all Prentice classes held in 1989.

The final 1969-70 faculty for Prentice was composed of Mr. Dailey, principal; Mrs. Junnie Craig, Mr. Charles Kidd, Mr. Arthur Greenlea, Mrs. Jewel Dailey, Mrs. Margaret Bergstresser, Mr. Glen Hale, Mrs. Judy Smitherman, and Ms. Delois Patrick. Further directives from the Justice Department called for the closury of the four Shelby County Negro High Schools and the final graduation class of Prentice held their exercise. ### **Mount Era School**

Little information is available on Mount Era School, but many references to the school were made in the submitted stories. It was located near the present Mount Era Methodist Church on Shelby County Highway 26 East.

The accompanying photograph was made available by Mrs. Ruth Naish Harris of Camp Branch. Mrs. Harris' mother, Iva Drucilla Lynch Naish (1891-1980), and uncle, Sidney Eli Lynch (1886-1959) are pictured in the third row from the front. They are the taller boy and small girl, shown side by side, in almost the exact center of the row.




Mount Era School, ca 1898-1900.

### ORDINANCE NO. 07222024-140

AN ORDINANCE TO AMEND CHAPTER 22,
OF THE CODE OF ORDINANCES OF THE CITY OF MONTEVALLO, ALABAMA
TO CREATE ARTICLE VII SECTION 22-140 REGARDING THE PRIVILEGE OR
LICENSE TAX FOR THE BUSINESS OF RENTING OR FURNISHING ROOMS,
LODGINGS, OR ACCOMMODATIONS TO TRANSIENTS

WHEREAS, The City of Montevallo under authority granted by the State of Alabama Code Title 40-26-1, et. seq., Revenue and Taxation, currently collects a privilege or license tax from every person, firm, or corporation engaging in the business of renting or furnishing any room or rooms, lodging, or accommodations to transients in any hotel, motel, inn, tourist camp, tourist cabin, or any other place in which rooms, lodgings, or accommodations are regularly furnished to transients for a consideration at the rate of five percent (5%) of the charge for such room, rooms, lodgings, or accommodations, including the charge for use or rental of personal property and services furnished in such room.

WHEREAS, given the current economic circumstances and conditions, both regionally and nationally, the City Council believes it is necessary, advisable and in the best interest of the City to increase the percentage of lodging tax imposed on those businesses that benefit most from the privilege of doing business in Montevallo.

**NOW THEREFORE BE IT ORDAINED** by the City Council of the City of Montevallo, Alabama as follows:

**Article VII. - LODGING TAX LEVY MODIFIED,** is hereby added to the Code of Ordinances of the City of Montevallo

### Article VII, Section 22-140 - Levy and amount of tax modified.

The rate of percentage shall hereby be established at six percent (6%) of the charge for such room, rooms, lodgings, or accommodations, including the charge for use or rental of personal property and services furnished in such room.

The proceeds collected related to this ordinance shall be expended to support the general operations of the City of Montevallo, as directed and appropriated by the City Council.

### Section 22-141. Severability

Each section and provision of this ordinance is hereby declared to be an independent section or provision. If any section or provision shall be declared void, invalid, or unconstitutional, the remaining sections or provisions shall not be affected but shall remain in full force and effect.

This Ordinance shall become effective upon its passage and advertisement as provided by law. Collection of six percent (6%) tax levy shall become effective November 1, 2024.
