Present: Mayor Rusty Nix, Council Member David King, Council Member Lelia Mitchell, Council Member Kenneth Dukes, Council Member Sonya Swords, Council Member Martha Eisenberg. Quorum present.

Work Session Called to Order at 5:30 P.M. by Mayor Nix with Quorum present.

#### **Mayor Nix Called for Committee Reports:**

Mayor Nix called on Council Member King for Public Health and Safety Reports. Council Member King called on Chief Littleton for the Police Department Report. Chief Littleton reported there were 53 Total Reports for the month of February. See Appendix 1.

Council Member King called on Chief Davis for the Fire Department report. Chief Davis reported there were 66 Calls for the first half of February. See Appendix 2.

Council Member David King reported the Planning and Zoning Commission meeting was held last Thursday and a request will come before Council on March 10th, Group Home/ Conditional Use.

Mayor Nix called on Council Member Dukes for the Sustainability Reports. Council Member Dukes called on Kirk Hamby, Head of Public Works. Kirk reported leaf collection transitioning to cutting right of way; Free Dump Day will be held March 29th at the Recycling Center; paving estimates are underway for summer paving projects.

Council Member Dukes advised Arbor Board held its annual Arbor Day Celebration this past Saturday at the Recycling Center and it was a huge success with 1,000 bare root seedlings given away.

Mayor Nix called on Council Member Martha Eisenberg for Recreation, Preservation and Community Development. Council Member Eisenberg advised Sydney Aguilar, Director of Youth Sports and Recreation was at a ballgame and could not attend but submitted a written report. Council Member Eisenberg read the report. See Appendix 3.

Mayor Nix on Council Member Mitchell for Education, Arts, and Outreach. Council Member Mitchell called on Sarah Hogan Program Director Impact Montevallo. Sarah reported on the dangers of Nitrous Oxide; she and Maurice Valentine went to Montgomery to support the Montevallo High School Basketball team in the Elite 8; Impact is participating in Black History with an Alabama Accent at the Library; Impact, Montevallo Main Street, and The Legacy Project are partnering to have a Black Youth Banner Series completed for 2026; Impact is partnering with the Library for its inaugural Backyard Book Fest. See Appendix 4.

Council Member Mitchell called on the Montevallo Junior City Council (MJCC) Junior Mayor Mary Elizabeth House. Mary Elizabeth reported that the MJCC is participating in the Backyard Book Fest by organizing the Mad Lib activity; volunteering at the Backyard Book Fest; starting this week she will be giving youth achievements reports; Montevallo Day of Pageants was last weekend and Katie Simmons was crowned Miss Montevallo; the Wrestling Team had 13 people to state championships; Montevallo was represented at the Shelby County Showcase by students from all three schools and represented a whole lot of different things; Montevallo recognized their 2025 honor graduates at a reception this past week; boys soccer team placed 2nd and the girls soccer team placed 3rd at the shoot-out.

Council Member Mitchell advised Marissa Wilson, Director of the Parnell Memorial Library was unable to attend due to taking an online class. Council Member Mitchell read the written report of programs being held at the library: Mini music; Book Club; Black History Program; March calendar of events is posted; 4HClub; inaugural Backyard Book Fest. See Appendix 4.

Council Member Mitchell reported Montevallo Schools would be closed on Friday, March 7th; March 25th – March 29th will be Spring Break for the Montevallo Schools and the University of Montevallo; High School Concert Bands will be at Palmer Hall Auditorium March 9th at 3 pm and high school students from across the state will be participating in these activities.

Council Member Mitchell reported the University of Montevallo will have free application week February 24th – February 28th and will hold Preview Day on March 8th.

Montevallo Senior Center will be celebrating Black History Month Wednesday and all are invited.

Mayor Nix called on Council Member Swords for Finance, Economic Development & Tourism. Council Member Swords called on Adele Nelson, Executive Director, Montevallo Chamber of Commerce. Adele reported that the 3rd Annual Montevallo Community Grant closes March 1st; 6th Annual Blooming Bargains started February 22nd; Chamber Chatter will be delivered Friday; Chamber Luncheon will feature Montevallo's First Responders; Onion Sale order deadline is April 14th. See Appendix 6.

Council Member Swords advised Courtney Bennett, Montevallo Main Street had a conflict and could not attend Council. Council Member Swords read the submitted written report. 
