5:30 p.m. at City Hall

Present: Mayor Rusty Nix, Council Member David King, Council Member Lelia Mitchell, Council Member Kenneth Dukes, Council Member Brandelyn Nelson, Council Member Alyssa Green. Quorum present.

Work Session Called to Order at 5:30 P.M. by Mayor Nix with Quorum present.

Discussion of New Business Items:

- **Discussion of Approval of Parade Permit from Montevallo Chamber of Commerce** for the Annual Christmas Parade on Main Street Thursday December 4, 2025, 6:00 PM.
- **Discussion of Resolution 11242025-237**, declaring 2 Patrol Units and related equipment, as surplus to be sold at Public Auction. Listed in Appendix A.
- **Discussion of Resolution 11242025-236**, donating a 2017 Police Interceptor Patrol Vehicle to the Centreville Police Department.
- **Discussion of Resolution 11242025-238**, authorizing the Montevallo Police Department to apply for a Department of Justice Grant for the purchase of Bulletproof Vests in the amount of \$8,900.00 and the allocation of matching funds from Capital Reserves in the amount of \$4,450.00.

Mayor Nix Called for Committee Reports:

Mayor Nix called for the Public Health and Safety Reports. Council Member Dukes called on Chief Burr for the Police Department report. Chief Burr reported there were 51 Reports for the month of November and 968 Total Reports for the Year. See Appendix 1.

Council Member Dukes reported Chief Davis with the Fire Department was unable to attend the meeting and no written report was submitted.

Council Member Dukes called on Sarah Hogan Shaw for the Impact Montevallo report. Sarah reported Impact produced a YouTube video/ PSA on items that are available for purchase in local stores to make the public aware; she reported all three SROs are registered to attend the National Association of School Resource Officers (NASRO) and Officer Friedman is beginning his journey to become certified; Impact is assisting with decorating the Christmas Parade Float; Arty and Harmony will be coming back soon; Impact's Coalition Meeting will be on December 2nd at 9 AM.

Council Member Dukes asked about Housing Abatement process – City Clerk Gilbert advised if there is a home that needs weeds to be cut or other violation it goes to Code Enforcement first, letters are sent certified mail, if no response the Housing Abatement Board will meet to determine course of action.

Mayor Nix called for the Sustainability Reports. Council Member Mitchell called on Kirk Hamby, Director of Public Works. Kirk reported the banners are up for Veterans Day and the month of November; Christmas decorations will be going up December 1st – 3rd – it's a 5 day process that will be completed in

3 days; December 13th at noon, Wreaths Across America will be at the City Cemetery and Alabama National Cemetery and volunteers are needed; the Recycling Center will be closed Thursday, Friday, and Saturday for the Thanksgiving Holiday.

Pledge of Allegiance

Council Meeting was called to order at 6 P.M. by Mayor Rusty Nix.

Invocation Mayor Nix called on Council Member Dukes to give the invocation.

Approval and/ or corrections of the Minutes: 11.10.25 Minutes - Motion made by Council Member Mitchell, Seconded by Council Member Dukes, All Ayes, Motion passed.

Recognitions/Awards: None.

Opportunities for Citizens to speak to the Council: Bobby C.P. Pierson 1131 Oak St advised January 19th will be the MLK Day Parade/ March and requested Parade Permit. He invited everyone to participate.

Joyce Lewis 330 Reonda Ln Reported the Rotary Club held the Turkey Shoot, and it was fun. She thanked Chief Davis and Chief Burr for participating.

Cynthia Miller 5696 Hwy 10 read a letter by Stacy Serrano 171 Cambridge Cir referenced activities in Jemison; immigrants fear of persecution for immigration status; questions and requests of Council.

Hector Argueta 361 Samford St Questions after what happened in Jemison; contact by ICE; has city been contacted by ICE.

Daniel Miller 5696 Hwy 10 Concerns about how this effects local Hispanic community and citizens; where is the accountability; people should not have to live in fear.

Council Member Green Asked what we can say to anyone in fear to help immigrants feel safe.

Mayor Nix addressed concerns and advised we are not Jemison. Our police department has not been contacted by ICE and MPD is not going to arrest anyone based on the color of their skin; Federal law enforcement has not contacted our city.

Chief Burr will cooperate with local and federal law enforcement; he commented on the questions asked by citizens and advised people are not being stopped based on the color of their skin; people that are stopped are ones that are breaking the law; we do not arrest people based on the color of their skin

or to check on their immigration status. Everyone is treated with respect. Montevallo is not hunting people down.

Maria Serrano 445 Selma Rd people are worried about what could happen in the community based on what has happened in Jemison.

Mayor Nix Called for Committee Reports to continue:

Council Member Mitchell reported that the Historical Preservation Commission will meet the first Tuesday, December 2nd at 6 PM at the Parnell Memorial Library.

Council Member Mitchell reported that the Arbor and Beautification Board will meet on Tuesday, December 9th at 5 PM at the Parnell Memorial Library.

Mayor Nix called for Recreation and Community Development. Council Member Green called on Sydney Aguilar-Baugh, Director of Youth Sports. Sydney reported the youth midget football team placed 2nd; youth basketball will start the first week of December; Spring sports will open the second week of December; Montevallo Senior Center has had upgrades to the center – hired an activities director, Sharon Whatley; December 22nd having a re-grand opening/ open house and invites everyone to come and see the upgrades; seniors will be in the Christmas Parade this year; they have increased senior participation at the center and are in need of a 20 passenger van that is ADA compliant per Council Member Mitchell. Council Member Green spoke to Dr. Courtney Bentley regarding Parks and Recreation Board and reported meetings are to be scheduled soon.

Council Member Green reported that the Shoal Creek Park Foundation is having a clean-up day on February 28th, 2026, and invites the public to volunteer for this effort. See Appendix 3.

Mayor Nix called for the Education, Arts & Outreach Reports. Council Member Nelson called on Marissa Wilson, Library Director, Parnell Memorial Library. Marissa reported the Ruby Bridges had a great turn out and they were able to give anti-bullying books to the elementary school library and the high school; the library's Facebook page is down so notices are being posted on the city's Facebook page; library is closed for Thanksgiving; December 1st is Sherlock Holmes day and there will be an after school craft; Mini Music; Mini Movie; Pokemon Club; Homeschool Hub is December 5th; Family Fun night will be a Polar Express party; Book Art Christmas Tree on December 10th; Lego Book club for tweens and teens; Hope Dance and Arts will perform their Sugar Plum dance performance on December 12th and 13th; Cookies with Mrs. Claus will be December 13th. See Appendix 4.

Council Member Nelson called on Mary Elizabeth House for the MJCC report. Mary Elizabeth reported the MJCC is participating in the Window Decorating Contest this year and have already began to set up and hope it will be done by Wednesday; they didn't receive enough food donations for a drive but donated the food to food pantries at MHS; she gave an update on youth reports – basketball is in full swing; wrestling is off to a great start; Tennis tryouts were held this past week and matches will start in January; MHS soccer is hosting a fundraiser and you can purchase merchandise from their Facebook page.

Council Member Nelson reported schools are closed this week and the UofM is closed for the Thanksgiving holiday.

Mayor Nix called for Finance, Economic Development & Tourism. Council Member King reported the Finance Committee meets on the 4th Wednesday every month at 5:30 PM at City Hall and is open to the public. He recommended the meeting be moved to 4 PM and City Clerk Gilbert advised it was moved and had been posted.

Council Member King reported that MDCD was approved to match funds for the Park and Recreation Grant for the Scout Lodge.

Council Member King called on Adele Nelson, Executive Director, Montevallo Chamber of Commerce. Adele reported the Christmas Parade will be held on Thursday, December 4th and packets are still available; she reported the survey on Business Basics 2026 is still open; December Chamber Chatter will be delivered on November 28th; Chamber Holiday After Hours will be held co-hosted by the Shelby Chamber and held at Indigo Café + Bar on December 11th from 5:30 PM – 7:30 PM; 9th Annual Christmas Open House will be held Friday December 12th – 15th; Mural Ribbon Cuttings will be held on Saturday, December 13th. Council Member King advised Courtney Bennett, Montevallo Main Street was unable to attend Council Meeting, but a written report was submitted. Council Member King read the report: the annual tree lighting will be at 5:30 PM on the post office lawn on Thursday; the winners of the 9th annual Storefront Decorating Contest will be announced before the Christmas Parade; December 13th will be the Ribbon Cutting for the two new Murals; the 7th annual Volunteer and Member Appreciation Holiday Party will be held on December 17th from 5:30 PM – 7:30 PM; the 2nd Annual Monte Gras Ball will be held at Liberty Hall at American Village on February 7th from 6 PM – 10 PM and sponsorships are currently available; new this year, Krewes – Our next “How to Start a Krewe” workshop will be held Thursday, December 11th at 6 PM. 
Other Business: Council Member Green asked about having magnets made to promote Council Meetings to engage the community.

The [Patrick Leahy Bulletproof Vest Partnership \(BVP\) Program](#), administered by the [Department of Justice, Office of Justice Programs \(OJP\)](#), [Bureau of Justice Assistance \(BJA\)](#), reimburses states, units of local government, and federally recognized Indian tribes for up to 50 percent of the cost of body armor vests purchased for law enforcement officers. Since 1999, more than 13,000 jurisdictions have participated in the BVP Program, with a total of \$573 million in federal funds for the purchase of more than 1.5 million body armor vests. Since FY 2015, body armor vests were directly attributable to saving the lives of at least 305 law enforcement and corrections officers (based on data collected by OJP). Forty-three of those body armor vests were purchased, in part, with BVP funds.

Program Requirements and Instructions

The following is an overview of the BVP requirements and instructions. Detailed information can be found in the [BVP Frequently Asked Questions \(FAQs\)](#).

Eligible Applicants: States, units of local government, and federally recognized Indian tribes—that is, jurisdictions—that employ eligible law enforcement officers are eligible to apply for BVP funds. For the purposes of the BVP Program, "state" means each of the 50 states, the District of Columbia, the Commonwealth of Puerto Rico, the

United States Virgin Islands, American Samoa, Guam, and the Northern Mariana Islands; "unit of local government" means a county, municipality, town, township, village, parish, borough, or other unit of general government below the state level.

Law Enforcement Officer Definition: "Law Enforcement Officer" is defined as any officer, agent, or employee of a state, unit of local government, or federally recognized Indian tribe authorized by law or by a government agency to engage in or supervise the prevention, detection, or investigation of any violation of criminal law, or authorized by law to supervise sentenced criminal offenders. This includes full-time, part-time, and auxiliary personnel, whether paid or volunteer.

Small Jurisdiction Priority Funding: By [statute](#), funds are first allocated to qualifying units of local government with fewer than 100,000 residents. Any remaining funds are then awarded to other qualifying applicants.
