#### Mayor Nix Called for Committee Reports:

Mayor Nix called on Council Member King for Public Health and Safety Reports. Council Member King advised Chief Littleton had a conflict and could not attend Council but submitted a written report. Council Member King presented the Police Report. There were 78 Total Cases the month of January. See Appendix 1.

Council Member King called on Chief Davis for the Fire Department report. Chief Davis reported there were 131 Total Calls for the month of January. See Appendix 2.

Council Member David King reported the Planning and Zoning Commission would meet at 6 p.m. on February 20<sup>th</sup> at City Hall.

Mayor Nix called on Council Member Dukes for the Sustainability Reports. Council Member Dukes called on Kirk Hamby, Head of Public Works. Kirk reported there was one tree down that was cleared and the department is preparing for the rain by clearing culverts, ditches, and drains; he would appreciate Mayor and Council's vote for the much needed leaf vacuum. Council Member Dukes advised there were tree limbs on Oak St. that need to be cut back.

Council Member Dukes advised Arbor Board will be holding its annual Arbor Day Celebration on February 22 from 8 am until noon at the Recycling Center and invited everyone to come to the event.

Council Member Dukes reported the Historical Preservation Commission (HPC) will not meet in March.

Mayor Nix called on Council Member Martha Eisenberg for Recreation, Preservation and Community Development. Council Member Eisenberg reported there is no report at this time.

Mayor Nix on Council Member Mitchell for Education, Arts, and Outreach. Council Member Mitchell called on Sarah Hogan Program Director Impact Montevallo. Sarah reported that the Mentoring Groups at the Middle and High Schools are going well, and they are seeking speakers; Impact is redesigning and printing banners for the Sports Fields at Stephens Park encouraging positive behaviors; Inaugural Prevention Day at the AL State Capitol will be on April 23<sup>rd</sup>, 9 a.m. -12:30 p.m.; Federal Funds have been released for Impact's grant-funding; March is Mental Health Month. See Appendix 3.

Council Member Mitchell called on the Montevallo Junior City Council (MJCC) Junior Mayor Mary Elizabeth House. Mary Elizabeth reported that the MJCC is partnering with the Youth of Leadership County to spread the word about Safehouse, an organization that helps victims of domestic violence.

Council Member Mitchell advised Marissa Wilson, Director of the Parnell Memorial Library was unable to attend due to taking an online class. Council Member Mitchell read the written report: 2,978 Visits to the Building, 6,011 Circulation, 101 Phone Calls, 620 Wi-Fi & Computer Sessions, 577 Database Searches, 504 Program Participation, 46 Community Meetings; 38 Programs running in January. Council Member Mitchell reported the University of Montevallo and Montevallo Schools would be closed Monday, February 17<sup>th</sup> for Presidents Day.

Council Member Mitchell reported the American Village would be holding a birthday celebration for George Washington on February 17<sup>th</sup>.

Mayor Nix called on Council Member Swords for Finance, Economic Development & Tourism. Council Member Swords called on Courtney Bennett, Montevallo Main Street. Courtney congratulated the 3 winners of Main Street's "Bright Ideas" Pitch Contest Grants (Main Street Tavern, The Dive Bar, Falcon Art Supply); inaugural Monte Gras event was a huge success; she conducted a tour of downtown Montevallo for members of the Heardmont Senior Center; when American Village's Festival of Tulips begins Main Street and Montevallo Chamber will partner for the 6<sup>th</sup> Annual Blooming Bargains; 2025 Work Plans for Main Street is in Council packets for review. Adele reported that the 3<sup>rd</sup> Annual Montevallo Community Grant opened February 1<sup>st</sup>; Blessing and Dedication of Fire Truck will be held February 15<sup>th</sup>; Chamber Luncheon is February 19<sup>th</sup>; and 6th Annual Blooming Bargains will begin soon in partnership with Main Street. ## The Main Street Approach

The Main Street Approach is a time-tested framework for community-driven, comprehensive revitalization.

#### Your Roadmap to Revitalization

Every community and commercial district is different, with its own distinctive assets and sense of place. The Main Street Approach<sup>™</sup> offers community-based revitalization initiatives with a practical, adaptable framework for downtown transformation that is easily tailored to local conditions. The Main Street Approach helps communities get started with revitalization, and grows with them over time.

#### Main Street Fundamentals

- The Main Street Approach is centered around Transformation Strategies. A Transformation Strategy articulates a focused, deliberate path to revitalizing or strengthening a downtown or commercial district's economy.
- A program's work on Transformation Strategies should be organized around the Four Points: Economic Vitality, Design, Promotion, and Organization.
- A revitalization program's work and its Transformation Strategies – need to be informed by a solid understanding of local and regional market data, and sustained and inclusive community engagement.

#### What Are Transformation Strategies?

- Transformation Strategies generated through meaningful community engagement and informed by an analysis of the district's market position – help to guide a revitalization program's work. An effective Transformation Strategy serves a particular customer segment, responds to an underserved market demand, or creates a differentiated destination.
- Some "ready-to-use" strategies called Catalyst Strategies — fall into two broad categories: those that are focused on a specific customer segment and those that are focused on an industry, product, or service segment.

## What Are the Four Points?

Transformation Strategies are implemented through comprehensive work in four broad areas, known as the Four Points.

ECONOMIC VITALITY focuses on capital, incentives, and other economic and financial tools to assist new and existing businesses, catalyze property development, and create a supportive environment for entrepreneurs and innovators that drive local economies.

DESIGN supports a community's transformation by enhancing the physical and visual assets that set the commercial district apart.

PROMOTION positions the downtown or commercial district as the center of the community and hub of economic activity, while creating a positive image that showcases a community's unique characteristics.

ORGANIZATION involves creating a strong foundation for a sustainable revitalization effort, including cultivating partnerships, community involvement, and resources for the district.


This year, we are celebrating 9 years as a Designated Main Street Community (est. 2016)!

#### Ala. Code § 13A-7-22 (1975) Criminal Mischief In the Second Degree

Library: Alabama Statutes Edition: 2025 Currency: Current through the 2024 Regular Session. Citation: Ala. Code § 13A-7-22 (1975)

(a) A person commits the crime of criminal mischief in the second degree if, with intent to damage property, and having no right to do so or any reasonable ground to believe that he or she has such a right, he or she inflicts damages to property in an amount which exceeds five hundred dollars (\$500) but does not exceed two thousand five hundred dollars (\$2,500).

(b)

(1) Criminal mischief in the second degree is a Class A misdemeanor punishable as provided by law.

(2) Upon a second conviction of criminal mischief in the second degree within a five-year period involving damage to a church or other religious building, or damage to property in a church or other religious building, the defendant shall be sentenced to a mandatory minimum sentence of not less than 10 days in jail and upon a third or subsequent conviction of criminal mischief in the second degree within a five-year period involving damage to a church or other religious building, or damage to property in a church or other religious building.

religious building, the defendant shall be sentenced to a mandatory minimum sentence of not less than 30 days in jail.

(3) Upon conviction for criminal mischief in the second degree involving a church or other religious building or damage to property in a church or other religious building, the court shall order restitution as a first priority before the payment of fines, court costs, or other court ordered payments.

(2) By means of an explosion.

(b) Criminal mischief in the first degree is a Class C felony.

(a) The theft of property which exceeds two thousand five hundred dollars (\$2,500) in value, or property of any value taken from the person of another, constitutes theft of property in the first degree.

(b) The theft of a motor vehicle, regardless of its value, constitutes theft of property in the first degree.

(c)

(1) The theft of property which involves all of the following constitutes theft of property in the first degree: a. The theft is a common plan or scheme by one or more persons; and b. The object of the common plan or scheme is to sell or transfer the property to another person or business that buys the property with knowledge or reasonable belief that the property is stolen; and c. The aggregate value of the property stolen is at least one thousand dollars (\$1,000) within a 180-day period.

(2) If the offense under this subsection involves two or more counties, prosecution may be

commenced in any one of those counties in which the offense occurred or in which the property was disposed.

(d) Theft of property in the first degree is a Class B felony.

(a) The theft of property between one thousand five hundred dollars (\$1,500) in value and two thousand five hundred dollars (\$2,500) in value, and which is not taken from the person of another, constitutes theft of property in the second degree.

(b) Theft of property in the second degree is a Class C felony.

(c) The theft of a firearm, rifle, or shotgun, regardless of its value, constitutes theft of property in the second degree.

(d) The theft of any substance controlled by Chapter 2 of Title 20 or any amendments thereto, regardless of value, constitutes theft of property in the second degree.

(e) The theft of any livestock which includes cattle, swine, equine or equidae, or sheep, regardless of their value, constitutes theft of property in the second degree.

(a) A person commits the crime of theft of property if he or she:

(1) Knowingly obtains or exerts unauthorized control over the property of another, with intent to deprive the owner of his or her property;

(2) Knowingly obtains by deception control over the property of another, with intent to deprive the owner of his or her property;

(3) Knowingly obtains or exerts control over property in the custody of a law enforcement agency which was explicitly represented to the person by an agent of the law enforcement agency as being stolen; or


(4) Knowingly obtains or exerts unauthorized control over any donated item left on the property of a charitable organization or in a drop box or trailer, or within 30 feet of a drop box or trailer, belonging to a charitable organization.

(b) The limitations period for any prosecution under subdivision (2) of subsection (a) does not commence or begin to accrue until the discovery of the facts constituting the deception, after which the prosecution shall be commenced within five years.

#### An Ordinance Establishing the Salary of the Mayor and Councilmembers

#### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MONTEVALLO, ALABAMA AS FOLLOWS:

**Section 1.** That the salary of the Mayor of the City of Montevallo, Alabama shall be and the same is hereby fixed at the sum of \$2,250.00 per Month.

**Section 2.** That each Councilmember of the City of Montevallo, Alabama shall be compensated at the sum of \$ 500.00 per Month.

**Section 3.** This ordinance shall become effective on the first Monday in November, 2025, and shall continue in force and effect until repealed by action of the Council.

**Section 4.** The provisions of this ordinance are hereby declared severable; if any portion of this ordinance shall be held unconstitutional or otherwise invalid by a court of competent jurisdiction, such ruling shall not affect the remaining portions of this ordinance.
