**Organization Committee** – Committee Chair, H. Lehman, had no report.

**Design Committee** – Committee Chair, K. Lightfoot, reported reported that Public Works is still watering the new plants at the post office and they will fertilize in partnership with the Arbor Board at the appropriate time; Facade Grants will open again next year; we are still preparing for a potential tour of up to 50 participants from Main Street Now in May 2024 to visit Montevallo; we are also still working on a "wish list" of holiday decorations to propose that the city purchase using ARPA funds; thanks to EV Committee members for sprucing up the former Citgo station with a banner and planters; thanks to all businesses who purchased Bulldog window clings; remaining stock of Shining Star t-shirts are still for sale (small, large, XL, and 2XL); Christmas ornaments are still for sale as well.

**Promotion Committee** – In the absence of Committee Chair Carolyn Garrity, Courtney Bennett reported that a portion of the committee met to discuss Small Business Saturday plans and distribute swag, and the full committee is scheduled to meet next week.

**Economic Vitality Committee** – In the absence of Committee Chair Ken Jones, Courtney Bennett reported that Day of the Dead went very well and thanks to the committee for allocating some funds to support it; we are also proud Snow Sponsors of the Merry Market being organized by Montevallo Arts Collaborative on November 25; our next CO.STARTERS cohort will begin August 27, 2024, meeting on Tuesdays from 6-9 PM at UM; the committee will be happy to assist in the efforts to build and promote the African American Heritage Trail being formed, two sites of which are located in the District.

**Sustainability Committee** – Committee Chair, J. McDonald, reported that floodwater modelling and water quality data collection are still underway; discussion is being had regarding the possibility of adding more bioswales in relevant areas in town; volunteers are needed for UM's Environmental Education program--please contact Jecca Thomason for more information.
