In the absence of Committee Chair, Julie Smitherman, Kirk Lightfoot reported that Tonia Mayton will be taking over Facade Grants this year, and artwork from ages 5-18 is still being accepted for our new Black History Month banner series (deadline: April 1).

Promotion Committee:

Committee Chair, Sarah Hogan Shaw, reported that bands for Friday Nights at the Cove have been booked, and 3 sponsors are still being sought; Adele Nelson reported that Blooming Bargains is getting a positive response from participating merchants, demonstrating that the Festival of Tulips at American Village is bringing visitors into downtown Montevallo; volunteers will be needed during Spring Fling on April 26 at the Pecan Grove; 6 food/drink vendors have been confirmed, and more are being actively solicited, thanks to the hard work of Patricia Honeycutt; advertising about this event will begin soon; this year we will install banners downtown for "Bulldog Pride" with a QR code instead of creating a poster; ideas are being discussed for the next round of Main Street Alabama grants; meetings have been held regarding the Media/Marketing Ambassador



Committee; ideas are welcome regarding how to celebrate our 9 year anniversary of Main Street Designation this June.

Economic Vitality Committee:

Committee Chair, Ken Jones, reported that the committee continues to discuss the possibility of forming a 501(c)3; and through their Supporting Arts Events and Programs work plan, they will sponsor Arts Fest on April 19 and possibly performances at Juneteenth on June 19 if requested by the Parks & Rec Board; discussion was had regarding the large number of visitors continually coming to Montevallo and what a positive impact the hotel will have on our local economy; and brochure racks are planned to be installed in high-traffic places such as Regions, Trustmark, Parnell Memorial Library, etc. with information about the Hydrant Trail, Public Art, upcoming events, etc.
